Eligibility: Swimmers must currently be registered with USA Swimming as a member of one of the invited teams. Swimmers must be within entered age brackets as of November 6, 2022. No deck registration shall be permitted.

Entry Deadline: Entries must be received no later than **noon** on Monday, October 24, 2022. No on-deck registration will be permitted.

Entry Limit: Swimmers may enter a maximum of three individual events

<u>Meet Format & Specifics</u>: The meet will be run in SCY. All events will be pre-seeded timed finals and swum as mixed gender. Age limits/guidelines are designated on pages 4-5 (Order of Events). Over swimmer starts will be used.

The session will be limited to no more than 4 hours. Entries may be limited to comply with these time limits.

Entries: Please submit a Hytek entry file to brandon@corvallisaquaticteam.org. With submission of entries, the coach/team representative attests that all swimmers entered are registered with USA Swimming. **Entries are due at noon on Monday October 24**th.

Awards: No awards.

Facility: Competition Pool:8 lanes, 7-ft 25-yard lanes, 30-in tilted blocks. Depth: 6ft to13 ft. Warm-up/Cool-Down: Shallow end of indoor pool east of bulkhead, 8 lanes and outdoor 25 meter pool, 6 lanes. The competition course has not been certified in accordance with 104.2.2 C(4).

<u>Seating/Live Feed:</u> Spectator seating is limited to the balcony and the deck on the non-competition end of the pool. A live feed <u>may</u> be available on social media (Facebook and/or Instagram).

<u>Timing:</u> Daktronics timing system, horn start, and finish touch pads. Results via electronic scoreboard. Names will appear as received in meet entries.

Pool Hours: The facility will not be open to the public during the competition. Participants may not enter the facility prior to the scheduled warm-up time.

<u>Times:</u> Warm ups and the meet will begin <u>no earlier</u> than the posted times below. Actual start times will be announced via email and posted on the CAT website as soon as entries are complete.

Rules: Current USA Swimming and Oregon Swimming Inc. rules, will govern this meet.

MAAPP: All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP") and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

Tech Suits: As of September 1, 2020, no Technical Suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet.

Safety: Current Oregon Swimming Safety Guidelines and Warm-up Procedures will be in effect and strictly

enforced.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

<u>Restrictions</u>: The deck is restricted to athletes entered in the meet, coaches with athletes entered in the meet, meet staff, meet officials, and facility employees. No spectators except meet volunteers and timers may access the pool deck. No glass containers, tobacco products, or alcoholic beverages are allowed in the pool facility. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Cell phones and photography are not allowed behind the blocks. Deck changing is prohibited. Operations of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
