Deck-Seeded. Positive check in required 30 minutes after the start of warmups.

Entry Fees:	 \$3.00 OSI surcharge per swimmer \$5.00 individual event fee Entry fee must accompany master pdf entry form and must be received prior to the start of the meet. Entry fees are due January 16th, 2023. Make checks payable to: The Dolphins Swim Team. If the event is canceled due to COVID-19 or adverse weather, a refund of the meet entry fees will be made by January 24th, 2023.

No Coach Present:	Only swimmers from the attending teams may enter the meet, no exceptions.
Meet Format:	All events will be PRESEEDED EXCEPT FOR the 400 IM, 500 and 1000 Freestyle which will be DECK-SEEDED and require positive check in, deadline 30 minutes after the start of warmups. Races will be MIXED and swam SLOWEST to FASTEST. Over swimmer starts will be used. Coaches are encouraged to report known scratches prior to the start of the meet. Breaks may be added at the discretion of the Referee.
	No Spectator Heat Sheets will be sold at the event. Heat Sheets for all Pre-seeded events will be available 24 hours prior to the meet on the Dolphins website for families to print and/or download their own. Heat Sheets will be posted at the venue and also available on Meet Mobile for free download.
Facility:	Indoor 25 yard, 6 lane pool, all of which will be used for competition. Starting blocks in the deep end only. Pool depth 9 ft at the start end and 3 ft 6 in at the turn end. Lanes are 7-9 ft wide and separated by five-inch non-turbulent lane lines.
	The competition course has not been certified in accordance with 104.2.2 C (4).
	Only those parents who are timing are allowed in the starting area. SWIMMERS, COACHES & OFFICIALS ONLY PLEASE AT THE START END OF THE POOL.
	The pool deck area is open and can accommodate two-way foot traffic and limited seating for swimmers and spectators for younger swimmers (9 years old and under).
	Swimmers should bring camping chairs in case the bleacher chairs do not provide enough seating.
Timing:	Timing will be two buttons and two backup watches. Pads will be used if they become available.

Swim Venue: Bathrooms for Athletes:


- Inside Men's locker room

Bathrooms for Adults:

The same bathrooms as for Athletes will be used. Volunteers will ensure that MAAPP is followed.

Pool deck areas available for swimmers, coaches, volunteers, and officials only.

The locker room space is limited. Swimmers should arrive in their swim apparel.



Meet marshals (4) will be on deck for warm-ups.

No indoor or outdoor spectator allowed except for swimmers 9 and younger and the first time meet participants

No concessions will be available at this meet.

- Pool Hours: Pool will be open from 7:15 AM until the conclusion of the meet to meet participants (spectators are allowed only for swimmers 9 and younger and the first time meet participants).
- **Restrictions:** There will be NO TOBACCO PRODUCTS OF ANY KIND, NO ALCOHOLIC BEVERAGES, AND NO GLASS CONTAINERS allowed in the swimming venue including the deck area or locker rooms. The use of audio or visual recording devices, including a cellphone, is not permitted in changing areas, rest rooms, or locker rooms. Photography is prohibited behind the blocks. Video or photography is prohibited in or over the water by devices such as a GoPro. Operations of a drone, or any other flying apparatus, is prohibited over the venue (pool, athlete/coach areas, spectator areas and open–ceiling locker rooms). Deck changing is prohibited.

Locker room space is limited. Swimmers should arrive in their swim apparel.


All adult participants must sign MAAPP acknowledgement form at check-in (entrance area).

Tech Suits:	No Technical Suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet.
Safety:	Current Oregon Swimming safety guidelines and warm-up procedures will be in effect and will be strictly enforced. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water.
Medical:	Medical facilities available include lifeguards, an AED, and community 911 EMS.
Warm-Up and Competition:	Warm-up lanes are directed by the team coach.
Procedures:	Fly over starts may be used, but will be determined based on the number of entries received and will be communicated out when heat sheets are distributed.

Bull Pen:	No bull pen will be provided
Awards:	No Awards will be provided
Heat Sheets:	Heat sheets with timelines will be available on the TDPS website in the 'Events/Meets' section prior to the meet and on Meet Mobile
Meetings:	Officials' meeting: One hour prior to the start of the meet. Coaches' meeting: 8:35 AM next to the hospitality area at the conclusion of warmups. (see map page 4)
