Basic Board Member Duties

This starts with an understanding of the fundamental legal duties of each individual board member, which include:

- **Duty of Care** Each board member has a legal responsibility to participate actively in making decisions on behalf of the organization and to exercise their best judgment while doing so.
- **Duty of Loyalty** Each board member must put the interests of the organization before their personal and professional interests when acting on behalf of the organization in a decision-making capacity. The organization's needs come first.
- Duty of Obedience Board members bear the legal responsibility of ensuring that the organization complies with the
 applicable federal, state, and local laws and adheres to its mission.
- **Duty of Transparency** Establish a system of operation that allows outsiders to see how the organization operates, makes decision, and uses resources.

Determine mission and purpose.

It is the board's responsibility to create and review a statement of mission and purpose that articulates your LSC goals.

Select, support and evaluate the chief executive.

Whether you have an Executive Director or a volunteer in charge, the board must reach a consensus on the chief executive's responsibilities and undertake a careful search to find the most qualified individual for the position.

Ensure effective planning.

The Board must actively participate in an overall planning process and assist in implementing and monitoring the plan's goals.

Monitor and strengthen programs and services.

It is the board's responsibility is to determine which programs are consistent with the LSCs mission and monitor their effectiveness. Also, to eliminate programs that aren't effective and add programs that help you reach your goals.

Ensure adequate financial resources.

One of your board's foremost responsibilities is to secure adequate resources for the LSC to fulfill its mission.

Protect assets and provide proper financial oversight.

The board must assist in developing the annual budget and ensuring that proper financial controls are in place. Reviewing the budget is so important – be sure to ask lots of questions if there is anything you don't understand about it.

Build a competent board.

All boards have a responsibility to articulate what they need in their candidates, orient new members thru the orientation process, and periodically evaluate their own performance. (This last one doesn't happen near as often as it should)

Ensure legal and ethical integrity.

The board is ultimately responsible for adherence to legal standards and ethical norms.
